RESOLUTION OF BOARD OF DIRECTORS MEETING OF THE ANTIOCH GOLF CLUB COMMUNITY ASSOCIATION (formerly known as THE HARBOR RIDGE HOMEOWNERS ASSOCIATION

This 29th day of October, 1991, pursuant to the covenants and bylaws of the Association, with the appropriate quorum present, the members of the Board of Directors hereby consent to, adopt and resolve, as our act and deed, the following:

WHEREAS, that on or about the 12th day of December, 1989, this Homeowners Association directed the Northern States Trust Company to execute a deed to the State Bank of Antioch, as trustee under a trust agreement dated September 21, 1989, and known as Trust No. 89-129, transferring title to the property legally described on Exhibit "A" attached hereto;

WHEREAS, it is the intent of this Association to relinquish any rights of ingress or egress by any members of the Homeowners Association or owners of property legally described on Exhibit "A" and found within the Final Development Plan recorded September 10, 1975 as Document No. 1728016, and the Antioch Country Club Final Development Plan Revision No. 1 recorded June 8, 1977 as Document No. 1841768;

WHEREAS, certain rights of ingress and egress to the property are contained in the Grant of Easements for General Ingress and Egress in the Declaration of Easements, Covenants and Restrictions recorded May 31, 1988 as Document No. 1920598;

WHEREAS, it is the intent of this Homeowners Association to relinquish any rights of ingress or egress along said property described in Exhibit "A" attached hereto; and

WHEREAS, this relinquishment of rights of ingress and egress along the property described in Exhibit "A" will not effect the rights of the members of the Homeowners Association for ingress and egress along the existing roadways located at the Antioch Golf Club;
